Homeownership Administration Charges

At ccha, we charge a fee for some of our homeownership services. Please refer to the table below for details.

As a responsible landlord, we recognise that all charges incurred on behalf of a homeowner must be both reasonable and fair. We must also be able to recover charges compliantly. ccha have adopted a commercial approach to the process of administration fees and unless otherwise stated expect payment prior to the activity commencing.

Administration fees are incurred when a homeowner makes a request for an administrative service or action for their individual needs which is not a service chargeable cost. Current housing sector practices focus on administration fees and the intention is to ensure that charges are fair, so it is imperative ccha charge fairly and do not pass these individual costs on to the rest of the homeowner community.

Historically, Housing Associations have put all costs related to homeowner management functions into the annual management fee. When this is the case and the Management Fee is accurately calculated, it normally results in a much higher fee, which may not prove sustainable, nor does it reflect good practice if all homeowners are paying a higher charge for the individual transactions of other homeowners.

ccha clearly defines the services we provide within our management fee. Everything else administrative must be subject to an administration fee where the Law and/or Lease permit.

Our administration fee approach covers instances where:

- a) there is a request for information or assistance and/or this request is determined to be over and above the strict requirements of the lease & statute.
- b) a lease transaction/transfer/assignment is taking place.
- c) a resident is in breach of the lease.
- d) an enquiry for a specific activity is requested by an individual resident for his/her personal benefit (alterations, pets, lease amendments, notices)

When assessing our fee, we consider the cost of delivering the specific request and also the reasonableness of our charge. The accepted approach to determining reasonableness is to identify and compare our charges with similar organisations in the sector. Appendix 1 shows a summary of the 'hi-lo' range of fees for specific chargeable activities across our sector, alongside the average fee for that activity (in 2014 & 2017 respectively). Appendix 2 shows the charging profile across c.45 Housing Associations.

Appendix 3 shows the fees charged by other similar sized Housing Associations from 2019/2020.

As we have recently launched our Homeowner service we have aimed to use a median charging profile for the majority of chargeable requests and once we are able to review our actual workload impact per chargeable activity and determine the cost of each activity, we will review the charges to ensure they reflect real costs whilst remaining reasonable.

Appendix 4 confirms the procedure for staff processing the charges.

- 2. Inform Homeowner/third party of cost.
- 3. Request Finance set up sundry debt and provide invoice.
- 4. Provide invoice to Homeowner/third party.
- 5. Collect payment and inform Finance.
- 6. Carry out work and provide to Homeowner/third party.
